We hope that you are all keeping well and warm as the colder weather sets in. This panui is to update you on some of our policy changes regarding the Te Pae o Waimihia grants, and to also advise of the new Kaumatua Healthy and Accessible Homes Grant.

The following information outlines the current grants and lists any changes to the processing dates, or Terms and Conditions that have occurred over the past few months. Please refer to the application form for each grant for the **full list** of Terms and Conditions.

PAKEKE / KAUMATUA MEDICAL GRANT

Subsidisation of medical treatments to Te Pae o Waimihia members aged 50 years and over.

Grant applications will be processed on the following months: February, March, April, May, June, July, August, September, October and November. Successful applications are required to be received by the 10th of the month for payment at the end of that month.

Updated Terms and Conditions:

- The grant will only be provided through a payment of invoice to the medical provider. Reimbursements to applicants will no longer be accepted. An invoice or quote along with the medical provider's verified bank account number is required.
- Applicants are only eligible to submit one pakeke/ kaumatua medical grant, per treatment, per calendar year.

SPORTING PARTICIPATION GRANT

Subsidisation of sporting related expenses.

Grant applications will be processed on the following months: February, May, August and November. Successful applications received by the 10th of the processing month will be paid at the end of that month.

SPORTING REPRESENTATION GRANT

Subsidisation of sporting related expenses for representative sports.

Grant applications will be processed on the following months: February, May, August and November.
Successful applications received by the 10th of the processing month will be paid at the end of that month.

EDUCATION GRANT

Subsidisation of education expenses for Year 0 to 10.

Grant applications will be processed on the following months: February, May, August and November. Successful applications received by the 10th of the processing month will be paid by the end of that month.

KAUMATUA HEALTHY AND ACCESSIBLE HOMES GRANT

We are pleased to advise you that applications are now open for the Kaumatua Healthy and Accessible Homes Grant. This grant has been established to contribute towards the funding for home developments to improve the health and accessibility for our Te Pae o Waimihia Kaumatua (ie. insulation, mobility ramps, hand rails, bathroom accessibility).

The applicant must be a registered member of the Tuwharetoa Settlement Trust, aged 70 years or over, and whakapapa back to one of the Te Pae o Waimihia hapu.

Applications will go through a needs assessment process and priority will be given to applications deemed to have the highest level of need.

The property must be occupied by the applicant and either owned by the applicant or his/her whanau, or part of a designated papakainga. The property must be located within the Taupo District Council rohe boundaries, and be permitted by the Taupo District Council.
